THE AWARENESS AND CAPACITY BUILDING ACCESS4ALL COURSE IS COMPLETED

IOI is coming to its finalisation. As a highlight, the consortium partners have developed different **Real Case Scenarios** addressing policies and/or actions of local authorities, municipalities or public bodies in their countries related to accessibility and disability. They entail short, yet meaningful, complementary studies to present and promote paradigms and **good practices of accessibility** in a range of situations, as well as to estimate the average amounts of budgeting, constructions and implementation limitations in regards to disabilities.

REAL CASE SCENARIOS

SPAIN

“**Accessible Medicine Plus**“, ONCE Foundation.

Free Mobile application to provide information on medicines to groups with some type of disabilities and the elderly. It is equipped with tools like scan drug code, pharmacy locator and a system of alert whether it detects an incompatibility of medicines with your allergies,

FRANCE

«**Centre de Rééducation et d'Insertion Professionnelle** » (CRIP). L'Union pour la gestion des établissements de caisses d'assurance maladie (UGEAM)

CRIP takes care of workers who suffered an accident or occupational illness and can no longer exercise their profession. It considers a professional retraining.

AUSTRIA

Project ARCHES - Inclusive Art Education. Arts History Museum of Vienna (Kunsthistorisches Museum Wien).

A barrier-free APP “ARCHES KHM für alle” where to find detailed object descriptions for blind and visually impaired people, as videos in sign language. The interactive tactile relief of Pieter Bruegel the Elder, The Nest Robberis set up in combination with a computer intuitively so that visually impaired people immediately receive audio information when they click.

ITALY

LIBERAMENTE- "the beach accessible to all", in the Municipality of Cerveteri.

It is worth noting the measure of "Chairs "JOB", wheelchairs designed specifically for the beach, as they do not sink into the sand, that allow people with disabilities to access the water in real comfort. They also count with specialized assistance staff.

CYPRUS

Project HERMES II - Tourism without Obstacles for Everyone Paralimni coast.

HERMES II offers tourism accessible for all at the beaches of Paralimni with inclusive infrastructure such as sea-tracks, land and sea wheelchairs, fitness equipment, sanitary facilities, a printed and a digital information guide. Similar accessibility actions were carried out in four more coastal cities of the island.

GREECE

“**Corfu Accessible Beaches Project**”. Corfu.

Twenty-one of the island's beautiful beaches are equipped with floating wheelchairs, which can easily be moved in and out of the water. This enables people with disabilities to access soft terrains and at the same time thanks to its floating armrests and oversized wheels, it can also safely float in water. The safety harness of the floating wheelchair secures its passengers when moving from sand to water.



2ND TRANSNATIONAL PROJECT MEETING

VIENNA, AUSTRIA

On 4th November the ACCESS4ALL consortium was finally able to meet in person in its **2nd Transnational Project Meeting (TPM)**.

During these two days of intense meetings, a variety of topics were discussed:

Furthermore, partners took the opportunity to visit the *Kunsthistorisches Museum Wien* through a tour especially coordinated for people with disabilities.
